I understand that I am giving up substantial rights by signing this document. I agree to use all recommended safety equipment and to abide by all warning and safety recommendations. **I agree that I will not participate in any activities, including without limitation those noted above, at Flint Hill Farm Educational Center, Inc. and Flint Hill Farm Ag while under the influence or alcohol or drugs.**
